In continuation to the notification issued vide notification No. Acad/REWS/499/2019 dated 18/01-2019, the Competent Authority of NERIST has approved the following:



No. 12-4/2019-U1 issued by DoHE, Ministry of Human Resource Development read with O.M.F.No.20013/01/2018-BC-II issued by Ministry of Social Justice & empowerment, Government of India. This shall be applicable from Academic year 2019-20.
- (3) The income and assets of the families as mention in Criteria of Income & Assets would be required to be certified by an officer not below the rank of Tehsildar in the States/UTs in the prescribed format.
